# Application for Emergency Tuition Fees Exemption for the Second Semester 2022

# **Notes for International Students**

Students who satisfy all the eligibility conditions for application below may be granted full exemption of payment of tuition fees for the second semester 2022.

Applicants should read these notes carefully and be sure to submit the correct documents.

Results of applications will be released early in January.

Submission period for applications: Tuesday, 11 October – 5 pm, Friday, 21 October 2022

# Eligibility for Emergency Tuition Fees Exemption for the Second Semester 2022

The following two conditions shall be met.

- 1 A person whose income for 2022 is less than 1/2 of the income for 2019, 2020 or 2021; provided that the income for 2022 should be 4 times the amount of sum of the incomes in July, August and September 2022.
- 2 Students who are recognized as having difficulty in their finances due to the effects of COVID-19, and who have excellent academic performance.

# **Required Application Documentation**

All documents indicated below are required.

- 1 Emergency Tuition Fees Exemption Application Form for the Second Semester
- 2 Certificate of income for 2019, 2020 or 2021 (Style C-1-1,C-1-2) (Example: passbook, withholding slip)

Please write the amount of income for 2019, 2020 or 2021. Please also attach a document that verifies the amount of your income. Please attach a Japanese translation of the document that confirms the amount of your income. A copy of the document or a hard copy of the screen is acceptable. If you don't have the documents to verify your income, you can't apply.

- ① In case that the student started to reside in Japan during the year 2019, 2020 or 2021, the amount of income for 2019, 2020 or 2021 should be the amount calculated as the equivalent of 12 months of the student's income earned in Japan.
- ② In case that the student resided outside of Japan in 2019, 2020 and 2021, the amount of income in 2019, 2020 or 2021 should be the amount of income of the main supporter of the household in

- 2019, 2020 or 2021. In this case, the amount of income in 2022 should also be the amount of income of the main supporter of the household in 2022.
- ③ In case that the student resided in Japan in 2019, 2020 or 2021, but reside in their home country during July to September in 2022, the amount of income in 2019, 2020 or 2021 should be the amount of income of the main supporter of the household in 2019, 2020 or 2021. In this case, the amount of income in 2022 should also be the amount of income of the main supporter of the household in 2022.
- 3 Certificate of income for 2022(Style C-3-1,C-3-2)(Example: passbook)

Please write your income for 2022.

When you fill in the actual amount of the income of July, August and September 2022, the amount of annual income will be calculated automatically. Please also attach a document that verifies the amount of your income. Please attach a Japanese translation of the document that confirms the amount of your income. A copy of the document or a hard copy of the screen is acceptable. If you don't have the documents to verify your income, you can't apply. The amount of income includes the remissions of money from home country, scholarships and the salary of your part time job.

### **Recognition of Excellence of Academic Records**

# Undergraduate students

Assessment will be based on undergraduate record in all subjects completed at the time of application. Applicants should have completed at least the standard number of units, with an average GPA of 2.70 or higher. Provided that the applicant is a first-year student who began in this October, this requirement is considered to be fulfilled.

#### Graduate students

Master course or Professional degree course students, applicants must have completed at least the standard number of units that each department or graduate school requires, with an average grade of 2.0 or higher. Provided that the applicant is a first-year student who began in this October, this requirement is considered to be fulfilled.

Doctoral course students, applicants recognized as having excellent academic records. Provided that the applicant is a first-year student who began in this October, this requirement is considered to be fulfilled.

\*Note: In calculating average grades, AA = 4, A = 3, B = 2, C = 1.

### Repeating year or exceeding the time limit of study students

If you are repeating the last year of your course or have exceeded the time limit of study more than a year, you are excluded from consideration for the tuition fee exemption.

The period of your leave of absence is included in your term of study in the handling of the tuition fees exemption.

Within budgetary constraints, the University will grant tuition exemptions based on domestic circumstances and academic record as detailed in submissions.

# **Important Advice for Applicants**

- 1. Applicants should read the instructions carefully.
- 2. The exemption of payment of tuition fee will be cancelled if it is discovered that any of the application materials were incorrect. If you fail to provide all of the required documents, your application will not be taken into account.

# Application Q & A

- Q1. According to the "Eligibility for Emergency Tuition fees exemption", students, who have lost a significant amount (50% or more compared to the previous year) of income due to the novel coronavirus pandemic, are eligible to apply. If I have lost 49% of my income, am I still eligible?
- A1. No, you are not eligible.
- Q2. If I fall into case a) and/or b), what should I do?
  - a) I am unable to make "Form C-1" because I cannot submit documents to verify my income for 2019, 2020 or 2021
  - b) I am unable to make "Form C-3" because I cannot submit documents to verify my income of July, August and September 2022.
- A2. We will not accept the application if you cannot submit the documents that confirm the income.

# <Important advice for applicants>

- -We do not accept case c) and/or d).
  - c) "The amount of income declared" is not stated.
- d) "The amount of income declared" is stated, but "the basis for the amount" is not provided.
- -"Roughly this much income" is not acceptable.
- -The contents of the application documents may be confirmed later. The inclusion in applications of information found to be false will lead to the cancellation of any exemption granted.
